- The fun Fun Run and 10k race will begin and end at the Metamora Grist Mill Park.
- Awards immediately following the race – so stay and enjoy a quiet visit in the country.

In consideration of permission for the undersigned participant(s) to enter, and participate in events, activities, and/or recreation at and/or on the Whitewater Canal State Historic Site and the Whitewater Canal Trail, Inc property, the participant(s), intending to be legally bound hereby, agree for participant(s)' heirs, executors, administrators personal representatives and assigns, that participant(s) *shall and hereby release and forever discharge Indiana Department of Natural Resources and the Whitewater Canal Trail, Inc, "Grantors"* and their officers, directors, employees, volunteers, and anyone who may be liable from any claims, actions, or causes of actions arising out of or related to any loss, damage, or injury, including paralysis and death which participant(s) may suffer while participating in any and all activities while on the grounds of the Whitewater Canal State Historic Site and the Whitewater Canal Trail, *regardless of whether such injury may be due to negligent act(s) or omission(s) of Grantors or otherwise.* Said events, activities, and/or recreation includes but are not limited to: running/walking event of any type or kind or participating in activities associated with the Towpath 10k Dash and Fun Run.
